**Tenure of Engagement** :

- The candidates who will be willing to work in any municipality or at any other office in the State shall be shortlisted initially for a period of one year which will be further extended upto three years more based on the satisfactory performance of the individual Expert.
- The candidates will provide their choice for three places of posting.
- Either party may terminate the employment by giving a mandatory minimum of 30 days' notice to the other party.
- The contractual services will be liable for termination at any time before the expiry of the contract period on account of poor performance or misconduct, by serving 30 days' written notice.

**Selection Procedure** :

- Preference will be given to the candidates having Doctor of Philosophy (PhD), Master Degree or Toppers of Bachelor's Degree.
- Directorate of Urban Local Bodies will scrutinise all the applications by a Screening-cum-Selection Committee and candidates will be shortlisted based on merits. The Committee will also conduct an interview of the shortlisted candidates.
- The Department may conduct a test of eligible candidates through reputed Government agency or Government controlled agency for selection of Experts.
- The decision of the said Committee shall be final and no correspondence will be entertained in this regard.

1. Latest passport size colored photograph. Photograph must be a recent passport size colour photograph with light background and covering 80% of the candidate's face.
2. **Scanned copy of signature of the applicant as per specification given below :-**
  - a. The applicant has to sign on white paper with Black Ink pen. Please crop the portion of signature from the scanned document and upload it in the application form.
  - b. The applicant must sign clearly so that the scanned image is clear and may be used for verification at the time of interview.
3. Self certified copy of the Detailed Marksheet Certificate/Degree of qualification.
4. Self certified copy of the experience certificate issued by organisation, if any.

## **IMPORTANT INSTRUCTIONS FOR FILLING ONLINE APPLICATION FORM**

1. Only online application submitted before the closing date will only be accepted. Application form sent in any other form will not be entertained and deems rejected.
2. The application complete in all respects will be accepted and application submitted without photograph/signature will be summarily rejected.
